

**EDWIN HARONIAN M D INC 401(K) PROFIT SHARING PLAN AND TRUST  
PLAN HIGHLIGHTS**

<b>Eligibility</b>	
<b>Excluded Employees:</b>	The following employees are excluded from the Plan: <ul style="list-style-type: none"> <li>• Employees covered by a collective bargaining agreement</li> <li>• Non-resident aliens</li> <li>• Employees covered under Code section 410(b)(6)(C)</li> </ul>
<b>Elective Deferral Contributions, Matching Contributions and Profit Sharing Contributions:</b>	You must meet the following criteria to be eligible to make Elective Deferral Contributions and receive Matching Contributions and Profit Sharing Contributions <ul style="list-style-type: none"> <li>• You must attain age 21</li> <li>• You must complete one (1) Year of Eligibility Service, during which you complete 1000 hours of service.</li> </ul>
<b>Enrollment Periods</b>	
<b>Elective Deferral Contributions, Matching Contributions and Profit Sharing Contributions:</b>	On the date you meet the eligibility criteria specified above.
<b>Contributions</b>	
<b>Elective Deferral:</b>	You may elect to defer from 0% up to 90% of your Compensation on a pre-tax basis. You may also elect to make Roth contributions to the Plan on an after-tax basis. You may elect to change your elections to contribute to the Plan on the dates established pursuant to Plan Administrator procedures. Federal law also limits the amount you may elect to defer under the Plan (\$19,500 in 2020). However, if you are age 50 or over, you may defer an additional amount up to \$6,500 (in 2020).
<b>Matching Contributions:</b>	The Company will make a Matching Contribution on your behalf in an amount equal to: (i) 25% of your contributions that are not in excess of 4% of your Compensation, plus (ii) 100% of the amount of your contributions that exceed 4% of your Compensation but that do not exceed 5% of your Compensation.
<b>Profit Sharing Contributions:</b>	The Company may, in its sole discretion, make a Profit Sharing Contribution on your behalf in an amount determined by the Company. Such contribution, if made, will be allocated to the Profit Sharing Contribution Account of each Participant eligible in pro rata shares. You must complete at least 500 Hours of Service during the Plan Year and be employed by the Company on the last day of the Plan Year in order to receive a Profit Sharing Contribution.
<b>Rollovers:</b>	The Plan may accept a Rollover Contribution made on behalf of any Eligible Employee, regardless of whether such Employee has met the age and service requirements of the Plan. An Eligible Employee who has not yet met any of the eligibility requirements of the Plan will be deemed a Participant only with respect to amounts, if any, in his Rollover Contribution Account.
<b>Vesting</b>	
<b>Fully Vested Accounts:</b>	You will have a fully vested and nonforfeitable interest in your Elective Deferral Account, Rollover Contribution Account and Qualified Nonelective Contribution Account.
<b>Matching Contribution Account and Profit Sharing Contribution Account:</b>	Your interest in your Matching Contribution Account and Profit Sharing Contribution Account will vest based on your Years of Vesting Service according to a 2-6 year graded vesting schedule (20% per year starting with two years of vesting service).
<b>Investing Plan Contributions</b>	
<b>Investments:</b>	You may direct the investment of all of your Accounts in one or more of the available Investment Funds. Your elections will be subject to such rules and limitations as the Plan Administrator may prescribe. The Plan Administrator may restrict investment transfers to the extent required to comply

	<p>with applicable law.</p> <p>The Plan is intended to constitute a plan described in section 404(c) of ERISA. This means that Plan fiduciaries may be relieved of liability for any of your losses that are the result of your investment elections.</p>
<b>Distributions and Loans</b>	
<b>Distributions from the plan:</b>	<p>You may receive a distribution from your account under the following circumstances:</p> <p>Immediately after your employment terminates</p> <p>After age 59-1/2</p> <p>Death</p>
<b>Loans:</b>	The minimum loan amount is \$1,000 and the maximum number of loans outstanding is 2.
